# **About Yayasan Mercy Corps Indonesia**

Yayasan Mercy Corps Indonesia (YMCI) is a local Indonesian non-profit organization, which implements humanitarian and development assistance programs throughout the country. YMCI's mission is to empower people in Indonesia to become healthy, productive, and resilient communities. Resilience means an ability to recover form or adjust easily to misfortune or change.

#### **Program Summary**

Mercy Corps Indonesia will support more than 300 women-led small entrepreneurs (with 5 to 19 employees) in the Greater Malang Region by increasing their access to financial services, training and mentoring and business development. We will use the partnership model to provide services to entrepreneurs while building the network and infrastructure that will support entrepreneurs of tomorrow. We will leverage existing relationships with financial institutions, chambers of commerce, business service providers, community business organizations and peer networks to connect women entrepreneurs with markets (inputs, finance and outputs) with a particular focus on mobilizing financial products. At the end of the project, at least 300 women entrepreneurs will participate in training and mentoring activities; increase the use of formal financial services or other business inputs; improve its business activities; hire additional employees or report increased earnings.

#### **General Position Summary**

The Program Officer will support the CAMELIA Program Manager to ensure 300 women entrepreneurs increase their knowledge of financial literacy, open a new savings account, access to loans, and use of digital payment transactions. He will lead program planning, implementation, and monitoring in each program work area and work closely with district government agencies, the private sector, communities, and CAMELIA partners.

# **Essential Job Responsibilities**

- Support the CAMELIA Program Manager to ensure at least 300 women entrepreneurs participate in a series of CAMELIA program activities such as training, mentoring, webinars, and participants' access to financial institutions.
- Prepare plans, monthly work targets, and provide monthly achievement reports against targets and work plans.



- Supervise program facilitators who provide training and mentoring to participants both online and offline. And ensure that the facilitators conduct the activity according to the program deliverables.
- Work with the Training & Mentoring Officer to design a capacity-building plan (training, workshop, comparative study, etc.) and ensure field activities (training, mentoring, outreach events, etc.) to achieve program deliverables indicators.
- Collaborate with Financial Services and Business Development Officers to increase women entrepreneurs' access to financial literacy, increase saving behavior, access to business loans, digital payment services, and increase business development literacy to achieve program deliverables indicators.
- Work with Monitoring, Evaluation, Research and Learning Officers to ensure data availability for monitoring, evaluation, and program learning reports.

## **Qualifications:**

- University degree in Economics, Business, Social Sciences, Agriculture, or a related field.
- Experience of more than 2 years working in development programs emphasizing economic development in rural areas (experience in training and mentoring programs for women entrepreneurs or financial literacy will be an advantage).
- Experience in mobilizing entrepreneurs, conducting economic research, assessments, and surveys.
- Experience in conducting training to entrepreneurs on saving practices (sources and content of the training will be provided by Mercy Corps).
- Experience using digital data collection tools to monitor the progress of beneficiary entrepreneurs.
- Moderate English and have the ability to communicate in the local language at the participants location.
- Experience working with local government agencies (particularly the Ministry of Cooperatives and SMEs, Ministry of Trade, and District Governments) and the private sector.
- Computer skills with strong familiarity with Microsoft Word, Excel, and PowerPoint.
